QUALIFICATION REQUIREMENTS

1. Be in a dual enrollment program, unpaid work-based learning program or CTE Courses.
2. Be enrolled in the CTE Project funded under this program.
3. Be in regular attendance of the VTEC CTE project and meet the training institution's attendance requirements.
4. Maintain satisfactory progress in his or her program of study according to the training institution's published standards for satisfactory progress.
5. Be a member of a "special population" -

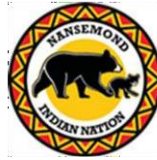
